Dr. Kulsrud joined the faculty in 1979 after receiving his Ph.D. from the University of Texas. He has also served as an editorial adviser to The Tax Adviser, Journal of Accountancy and Journal of the American Taxation Association. In addition to his contributions as an author and editor, Dr. Kulsrud has received many awards for outstanding teaching. In 1990 he was named Accounting Educator of the Year by the Indiana C.P.A. Society. He has also taught hundreds of professional education programs for national and local accounting firms and has developed materials used in their continuing education programs. Dr. Kulsrud is currently the co-coordinator of the National Tax Education Program sponsored by the AICPA.
